2.Government's quasi-public system policy for private kindergartens launched in 2019, that subsidies were higher than childcare subsidies (allowance), and people could only choose one to apply; hence the figures of beneficiary-times and amount are zero in 2019 and 2020. Besides, as "Regulations For Subsidizing Life Assistance As Well As Nursery And Medical Expenses Of Disadvantaged Children And Youth" modified its childcare subsidies (allowance)'s objects,amount and application in November 2020, and cancelled the requirement that some subsidies of the same nature can not be claimed at the same time; hence this report had related statistical results in 2021.

3.The data of Welfare Services (No. of Beneficiary-times) was times of attended persons of recreation activities before 2021, and it turned to be beneficiary-times of case service, group service, community service, outreach service, referral service as well as times of attended persons of parenting education and family activities since 2021.
