

Tax Service Calendar

January	
10	◆ The declaration of the amusement tax of December is due today. In case of a holiday, the deadline will be postponed to the next day.
15	◆ The declaration deadline of November and December for the national and civilian enterprises or organizations granted for the total payment of the stamp tax. In case of a holiday, the deadline will be postponed to the next day.

February	
10	◆ The declaration of the amusement tax of January is due today. In case of a holiday, the deadline will be postponed to the next day.
28	◆ The last day of February of each year shall be the base date for the duty of paying house tax; the tax shall be assessed by the local competent tax authority based on the house tax registration data. In case of a holiday, the deadline will be postponed to the next day.

March	
10	◆ The declaration of the amusement tax of February is due today. In case of a holiday, the deadline will be postponed to the next day.
15	◆ The declaration deadline of January and February for the national and civilian enterprises or organizations granted for the total payment of the stamp tax. In case of a holiday, the

	deadline will be postponed to the next day.
22	<p>◆ In the event of a change to the use of a house, the taxpayer shall report the change to the local competent tax authority at least forty (40) days in advance of the commencement of the collection period for each taxable year, except where the change has led to an increase in the amount of tax payable, the taxpayer shall report the change to the local competent tax authority at least forty (40) days in advance of the commencement of the collection period for the taxable year following such change. After the house tax has been assessed following such change, unless there are other changes to the house, no further such report is required. In the event of a change to the use of a house resulting in a decrease in the amount of house tax payable, if the taxpayer fails to report the change in time, the new tax rate will become applicable from the taxable year following the taxpayer's report; where the change results in an increase of the amount of tax payable, the new tax rate will become applicable from the taxable year following the change, regardless of the taxpayer's late or failure to report such change. In case of a holiday, the deadline will be postponed to the next day.</p>

June

August

September
